

**A R R A N G E M E N T**  
**BETWEEN**  
**THE MINISTRY OF THE INTERIOR OF THE CZECH REPUBLIC**  
**AND**  
**THE MINISTRY OF DEFENCE OF THE ITALIAN REPUBLIC**  
**CONCERNING**  
**THE COOPERATION IN TRAINING IRAQI POLICE,**  
**WITHIN THE FRAMEWORK OF THE COUNTER ISIL GLOBAL COALITION**

The Ministry of the Interior of the Czech Republic, represented by Chargé d'affaires ad interim of the Czech Republic to Iraq,

and

the Ministry of Defence of the Italian Republic, represented by the Military Attaché at the Italian Embassy in Iraq,

hereinafter referred to as "the Parties";

TAKING INTO ACCOUNT that the Italian Party launched a training programme with the aim of delivering training and advising activities in favour of the Iraqi Ministry of Interior and Police (hereinafter referred to as "Training Programme") in the Republic of Iraq, in coordination with the Iraqi Ministry of Interior and within the framework of the Counter ISIL Global Coalition (hereinafter referred to as "the Coalition");

RECOGNISING that the Italian Police Task Force – Iraq (IT PTF-I) running the Training Programme in Iraq is embedded to the Combined Joint Force Land Component Command – Operation Inherent Resolve (CJFLCC – OIR);

RECALLING that the Italian Party, chairing the Police Training Working Group within the Coalition, invited the other Members in the Coalition to contribute to the Training Programme;

TAKING INTO ACCOUNT the intention of the Czech Republic to continue in participating in the Training Programme;

TAKING INTO ACCOUNT the Iraqi Government's approval of the deployment of Czech Police Officers to the Republic of Iraq in order to join the IT PTF-I;

AWARE OF previous cooperation under Arrangement between the Ministry of the Interior of the Czech Republic and the Ministry of Defence of the Italian Republic Concerning the Cooperation in Training of Iraqi Police, within the framework of the Global Coalition to Counter ISIL, signed in Baghdad on 26<sup>th</sup> March 2017;

DESIRING to define the conditions of the further cooperation between the Parties, inspired by the principles of the Agreement between the Czech Republic and the Italian Republic on Friendly Relations and Cooperation, signed in Rome on 23<sup>rd</sup> January 1996;

Have agreed as follows:

### **1. Purpose**

- 1.1 The purpose of this Arrangement is to define the conditions of the further cooperation between the Parties in the performance of the Training Programme in the framework of the Coalition.
- 1.2 Cooperation under this Arrangement shall take place in accordance with the national legislation of the States of the Parties as well as with provisions of the international agreements by which the States of the Parties are bound.

### **2. Contact Points**

The contact points set forth for the purposes of the cooperation under this Arrangement are:

For the Ministry of the Interior of the Czech Republic:  
Police Headquarters of the Czech Republic  
International Police Cooperation Department;

For the Ministry of Defence of the Italian Republic:  
Commander of IT PTF-I.

### **3. Training Cooperation**

- 3.1 The Czech Party intends to deploy 5 Police trainers to the Republic of Iraq to join the IT PTF-I. Czech Police trainers will be involved in the Training Programme in accordance with the training requirements of the Combined Joint Task Force – Operation Inherent Resolve (CJTF-OIR).
- 3.2 The contribution proposed by the Czech Party in terms of qualifications of the Czech Police trainers to be deployed to the Republic of Iraq within the framework of the cooperation under this Arrangement will be agreed between the contact points of the Parties; the scheduled courses and capabilities of the Czech Party will be taken into account. The Czech Party will inform the IT PTF-I about qualifications of the Czech Police trainers to be deployed at least 4 weeks before deployment.
- 3.3 The Parties confirm the common understanding that the Czech Police trainers will be given tasks by the IT PTF-I Commander.
- 3.4 The Czech Police trainers will be subject to the Czech law, including disciplinary and performance evaluation related issues which will be dealt with by the Czech Party.

### **4. Logistic Support**

- 4.1 The Czech Police trainers will be accommodated at Camp Dublin, together with the IT PTF-I trainers. Logistic support at Camp Dublin is provided by the Iraqi Federal Police Special Training School and by the IT PTF-I.

4.2 The Italian Party will ensure, on reimbursement basis:

- accommodation functioning and maintenance;
- fuel for generators;
- general services provided at Camp Dublin.

4.3 The IT PTF-I will provide the Czech Police trainers, on reimbursement basis, with transportation between Camp Dublin and Baghdad Diplomatic Support Centre (BDSC).

4.4 The Czech Party will reimburse the Italian Party for the costs under provisions 4.2 and 4.3 related to the demanded and delivered services provided to the Czech Police trainers according to the number of trainers deployed on a proportional basis. Costs for demanded services will be calculated by the relevant Italian Administrative Unit. The Italian Administrative Unit will deliver monthly a detailed invoice of the costs to be reimbursed. Prices charged to the Czech Party will be at the actual costs paid by the Italian Party. Costs estimate is illustrated in the Annex. Any change of cost will be notified by the IT PTF-I Commander.

4.5 The Czech Police trainers will take their meals at the BDSC, as the IT PTF-I trainers do. Payments for meals and other needed logistic support are to be dealt with by the Czech Party and the provider.

4.6 In case of need, the IT PTF-I will support, within means and capabilities, the Czech Police trainers with the First Aid procedures (nursing interventions) and transport to the BDSC for medical support.

### **5. Uniform and Equipment**

5.1 The Czech Police trainers, on the base of the agreements with the Iraqi Authorities, will wear their national uniform and will carry their service firearms, ammunition, coercive means, bullet proof vest and any other necessary equipment for the training activities and also for their own security.

5.2 The Parties are responsible for providing their own personnel with the required equipment, weapons and ammunition.

5.3 Weapons and ammunition will be stored in the IT PTF-I Armory at Camp Dublin. The Czech Party will inform the IT PTF-I about number and type of weapons in advance.

### **6. Internal Security**

6.1 Security support at Camp Dublin is provided by the Iraqi Security Forces. However, in order to increase the security conditions, a 24/7 guard roster is set up at Camp Dublin, performed by the IT PTF-I trainers, under the guidance of the IT PTF-I Commander. The Czech Police trainers will participate in the internal security duties and will be included in the 24/7 security roster.

6.2 Evacuation of the Czech Police Trainers in case of emergency will be ensured by the IT PTF-I, in close coordination with the United States Regional Security Office personnel. The IT PTF-I will acquaint the Czech Police trainers with the security rules.

6.3 Restriction of movements due to security alerts will be followed by both the Parties trainers.

## **7. Disputes Settlement**

Any dispute concerning the interpretation or implementation of this Arrangement will be resolved by consultations between the Parties.

## **8. Final Provision**

- 8.1 This Arrangement shall enter into force on the date of signature.
- 8.2 This Arrangement may be amended or terminated in written form by mutual consent of the Parties. All amendments shall enter into force on the date of signature.
- 8.3 Any Party may withdraw from this Arrangement by giving a one month notice to the other Party.
- 8.4 The Arrangement between the Ministry of the Interior of the Czech Republic and the Ministry of Defence of the Italian Republic Concerning the Cooperation in Training Iraqi Police within the framework of the Counter ISIL Global Coalition signed in Baghdad on 26<sup>th</sup> March 2017 shall be terminated on the date of the entry into force of this Arrangement.
