EXECUTIVE PROGRAMME OF CULTURAL, EDUCATIONAL AND SCIENTIFIC COOPERATION BETWEEN

THE GOVERNMENT OF THE CZECH REPUBLIC AND

THE GOVERNMENT OF THE ARAB REPUBLIC OF EGYPT FOR THE YEARS 2014 – 2017

The Government of the Czech Republic and the Government of the Arab Republic of Egypt (hereinafter referred to as the "Contracting Parties"), led by the wishes to strengthen and develop mutual cooperation in the field of education, science and culture in conformity with the Agreement between the Czechoslovak Republic and the Republic of Egypt on Cultural Cooperation signed in Cairo on 19 October 1957, have agreed to conclude the following Executive Programme of Cultural, Educational and Scientific Cooperation for the period 2014 – 2017:

Scientific research

Article 1

The Contracting Parties shall support direct cooperation between research institutions and cooperation in projects of common interest.

Article 2

The Contracting Parties shall support mutual exchange of scientific information, documentation and other materials.

Higher education

Article 3

The Contracting Parties shall support direct cooperation between higher education institutions established in the countries of the Contracting Parties as well as mutual agreements on such cooperation. Furthermore, the Contracting Parties shall support the activities of the Czech Institute of Egyptology in Egypt and other forms of cooperation in the area of Egyptology.

Article 4

(a) Each academic year, the Czech Contracting Party shall offer a scholarship for teachers at higher education institutions and scientists from the Arab Republic of Egypt for a total period of ten (10) months. This scholarship may be divided into scholarships for shorter periods of time which may not be shorter than one (1) month and longer than five (5) months.

- (b) Each academic year, the Egyptian Contracting Party shall offer a scholarship for teachers at higher education institutions and scientists from the Czech Republic for a total period of ten (10) months. This scholarship may be divided into scholarships for shorter periods of time which may not be shorter than one (1) month and longer than five (5) months.
- (c) The Contracting Parties shall arrange for scholarships of candidates nominated under this article of this Executive Programme upon the submission of invitations/approval of the host institutions with the stay and programme of the nominees.

Article 5

Each academic year, the Contracting Parties shall offer each other scholarships in doctoral study programmes the maximum length of which shall not exceed thirty-six (36) months per academic year.

Article 6

- (a) Each academic year, the Czech Contracting Party shall offer five (5) scholarships for Egyptian students to study the Czech language in Bachelor's and Master's study programmes at one of the Czech Republic's public higher education institutions; each of the scholarships being for a period of maximum five (5) months.
- (b) Each academic year, the Egyptian Contracting Party shall offer five (5) scholarships for Czech students to study the Arabic language in Bachelor's and Master's study programmes at one of Egypt's higher education institutions; each of the scholarships being for a period of maximum five (5) months.

Article 7

- (a) The Contracting Parties shall support teaching of the Czech language in the Arab Republic of Egypt and teaching of the Arabic language in the Czech Republic.
- (b) Upon request of the Czech Contracting Party, the Egyptian Contracting Party shall support sending of one (1) teacher at higher education institution to teach the Arabic language and literature at a selected Czech public higher education institution.
- (c) Upon request of the Egyptian Contracting Party, the Czech Contracting Party shall support sending of one (1) teacher at higher education institution to teach the Czech language and literature at the Faculty of Languages of the Ain Shams University in Cairo.

Article 8

The Contracting Parties shall, if need be, issue recommendations for higher education institutions (including Universities) in regard to recognition of certificates, university diplomas and academic titles acquired in the other Contracting Party's country.

Article 9

The Ministry of Education, Youth and Sports of the Czech Republic and the Ministry of Higher Education of the Arab Republic of Egypt shall support the exchange of two (2) experts responsible for the preparation and the implementation of the educational part of this Executive Programme,

with the aim of resolving the problems related to its implementation.

Each visit shall not exceed one (1) week. Conditions of each visit shall be agreed upon through diplomatic channels.

General and vocational education

Article 10

The Contracting Parties shall, upon request, send each other literature on education and education of adults as well as information about study programmes and curricula used by schools of various fields and various levels including institutions providing education for adults.

Article 11

The Contracting Parties shall, upon request, exchange information concerning the use of Information and Communication Technologies in education.

Article 12

The Contracting Parties shall inform each other about the events focused on pupils' and students' activities in the field of arts and environment and shall support the exchange of the results of their work in these fields.

Youth

Article 13

The Contracting Parties shall, upon request, exchange documents and materials from the area of youth.

Article 14

The Contracting Parties shall encourage the exchange of experience in the field of youth training and advanced training for youth leaders.

Article 15

The Contracting Parties shall encourage the exchange of views and experiences in the field of the development of youth institutions (scouts, girl guides, youth hostels).

Sports

Article 16

The Contracting Parties shall support contacts and exchanges between sports teams and individual sportsmen, coaches and experts organized and financed by relevant sports organizations.

Article 17

The Contracting Parties shall, upon request, exchange documents and materials from the area of youth activities, sports and physical education.

Culture and arts

Article 18

The Contracting Parties shall base their exchange of cultural and artistic values, which is specified in the Articles 19, 20, 21, 22 and 25, on the principles of the Convention on the Protection and Promotion of the Diversity of Cultural Expressions (Paris, 2005).

Article 19

The Contracting Parties shall support mutual exchange of the artistic ensembles for the purpose of attending festivals organized in the partner country in accordance with terms and conditions of the event.

Article 20

- (a) The Contracting Czech Party is ready to accept participation of Egyptian artists in the international art shows organized in the Czech Republic, e.g. International Exhibition of Scenography and Theatre Architecture the Prague Quadriennale 2015 in accordance with terms and conditions of the event.
- (b) The Contracting Egyptian Party is ready to accept participation of Czech artists in the international art shows organized in Egypt, e.g. Cairo International Biennale, Cairo International Biennale for Ceramics, Cairo International Triennale of Graphic and in accompanying symposiums in accordance with terms and conditions of the event.

Article 21

The Contracting Parties shall support mutual representation in the film festivals of both countries.

Article 22

The Contracting Parties shall support the participation of their artists at the international book fairs

which are held:

- in Czech Republic:
 - International Book Fair and Literary Festival Book World Prague organized every year in May
- in Egypt:
 - Cairo International Book Fair organized every year in January
 - Cairo International Children Book Fair organized every year in November

Libraries

Article 23

The Contracting Parties shall support execution of a special Memorandum of Understanding between the National Library of the Czech Republic and the National Library and Archives of the Arab Republic of Egypt in the field of libraries.

Article 24

The Contracting Parties shall support sharing of the written cultural heritage through the communication technologies.

Article 25

The Contracting Parties shall support translations of their national literatures, i.e. in particular translations of books of fiction from Czech to Arabic and vice versa.

Cultural heritage

Article 26

The Contracting Parties shall support direct cooperation between museums and galleries for purpose of exchange of exhibitions, participation of specialists in conferences, symposiums, scientific projects, research and other activities.

Specific conditions and terms shall be agreed directly between corresponding institutions.

Article 27

The Contracting Parties shall encourage the exchange of specialists in the field of museums and galleries and the exchange of information in the field of museology.

Article 28

The Contracting Parties shall encourage the participation of experts and specialists in the joint working groups organized in each country of the Contracting Parties for the purpose of experience exchange in the field of registry work carried out on the artifacts discovered in excavations, adopting the techniques of documentation and scientific publications, including learning and training in the use of the latest systems and methods of restoration, preservation and storage.

Article 29

The Contracting Parties shall support the cooperation between the institutions responsible for the preservation of cultural heritage of the two countries. The Contracting Parties have agreed on the exchange of documents and information on cultural heritage protection, preservation (preventive conservation) and restoration.

Article 30

The Contracting Parties shall cooperate against the illegal trafficking of cultural property through taking all necessary and preventive measures, according to their national legislations in force and compliance with the UNESCO conventions agreed by both Parties, and will take all necessary and precautionary measures to prevent such trade.

Article 31

The Contracting Parties shall support the exchange of exhibitions representing cultural heritage of both countries in accordance with the national laws ruling such exhibitions.

Details shall be agreed upon through diplomatic channels.

General and financial provisions

Article 32

The Sending Contracting Party shall ensure that the cost of international return fare to the place of stay in the country of the Receiving Contracting Party of persons accepted under this Executive Programme will be covered.

Article 33

When selecting persons for this Executive Programme, the Contracting Parties shall give preference to candidates who have command of the language of the country of the Receiving Contracting Party as well as of the English language.

Article 34

(a) When nominating candidates under Articles 4, 5 and 6 of this Executive Programme, the Sending Contracting Party shall submit documents containing information required in questionnaires of the Receiving Contracting Party by 31st March of the respective calendar year at

the latest. Candidates' personal data contained in questionnaires shall be subject to legal regulations of the countries of the Contracting Parties concerning the protection of personal data.

- (b) Nominations of candidates from the Czech Republic submitted under Articles 4, 5 and 6 of this Executive Programme shall be carried out based on the completed application forms and information about the nominees' language skills, programme of their stay and duration of their stay.
- (c) Nominations of Egyptian candidates submitted under Articles 4, 5 and 6 of this Executive Programme shall be carried out based on the completed application forms and attached documents which the application form specifies as obligatory.
- (d) The Receiving Contracting Party shall submit its opinion in regard to the acceptance of candidates before 1st July of each calendar year to the responsible institutions of the country of the Sending Contracting Party. The report on the accepted candidates must include address of accommodation, amount of scholarship and the length of stay.
- (e) The Sending Contracting Party shall inform the Receiving Contracting Party about the date of each candidate's arrival at least three (3) weeks in advance.

Article 35

Exchange of persons under Articles 4 and 5 of this Executive Programme shall take place under the following conditions:

- The Receiving Czech Contracting Party shall ensure that all persons accepted under Articles 4 and 5 of this Executive Programme will be granted:
 - a) Accommodation in university lodging facilities for guest teachers. If a candidate fails to appear at the address indicated in the Decision within two weeks following the date indicated in the Decision, he/she has to be aware of the fact that the reservation of the original accommodation may be cancelled, and as a result of this fact his/her beginning of the study stay may be postponed until a new accommodation facility is provided;
 - b) Scholarship in accordance with the valid legal and financial regulations of the host country which is currently set at 9 500,- Kč (Czech Crowns) per month; this amount may be increased should new internal legal and financial regulations of the country of the Receiving Czech Contracting Party come into force. The sum of 9 500,- Kč (Czech Crowns) includes the amount intended to cover accommodation costs.

The Receiving Egyptian Contracting Party shall ensure that all persons accepted under Articles 4 and 5 of this Executive Programme will be granted:

- a) Free hotel-style accommodation. If no such accommodation is available, the Receiving Egyptian Contracting Party shall pay to each candidate at least 400,- EGP (Egyptian Pounds) per month to cover the cost of accommodation which the accepted person finds himself or herself;
- b) Scholarship in the amount of 800,- EGP (Egyptian Pounds) per month; this amount may be increased should new internal legal and financial regulations of the country of the Receiving Egyptian Contracting Party come into force.

Exchange of persons under Article 6 of this Executive Programme shall take place under the following conditions:

- The Receiving Czech Contracting Party shall ensure that each Egyptian student accepted under Article 6 of this Executive Programme will be granted:
 - a) Free tuition;
 - b) Scholarship for students in Bachelor's and Master's programmes in accordance with the valid legal and financial regulations of the host country which is currently set at 9 000,-Kč (Czech Crowns) per month; this amount may be increased should new internal legal and financial regulations of the country of the Receiving Czech Contracting Party come into force. The sum of 9 000,- Kč includes the amount intended to cover accommodation costs;
 - c) Accommodation in student dormitories under the same conditions as for the Czech students. If a candidate fails to appear at the address indicated in the Decision within two weeks following the date indicated in the Decision, he/she has to be aware of the fact that the reservation of the original accommodation may be cancelled, and as a result of this fact his/her beginning of the study stay may be postponed until a new accommodation facility is provided;
 - d) Opportunity to use student catering facilities under the same conditions as for the Czech students.
- The Receiving Egyptian Contracting Party shall ensure that each Czech student accepted under Article 6 of this Executive Programme will be granted:
 - a) Free tuition;
 - b) Scholarship in the amount of 550,- EGP (Egyptian Pounds) per month; this amount may be increased should new internal legal and financial regulations of the country of the Receiving Egyptian Contracting Party come into force;
 - c) Free accommodation in university lodging facilities for guest teachers. If no such accommodation is available, the Receiving Egyptian Contracting Party shall provide to each candidate at least 250,- EGP (Egyptian Pounds) per month to cover the cost of accommodation which the accepted person finds himself or herself;
 - d) Opportunity to use student catering facilities under the same conditions as for the Egyptian students.

Article 37

- 1. The respective body of the Receiving Czech Contracting Party shall provide to each teacher accepted under Article 7 of this Executive Programme salary or emoluments of a teacher at a higher education institution in accordance with the valid legal regulations of the host country.
- 2. The Receiving Egyptian Contracting Party shall provide to each teacher accepted under Article 7 of this Executive Programme salary or emoluments of a teacher at higher education institution in accordance with the valid legal regulations of the host country.

3. Teachers are appointed for one calendar year and all possible extensions of their stay must be negotiated through diplomatic channels by 1st January of each year.

Article 38

The disbursement of scholarships under Articles 4, 5 and 6 of this Executive Programme shall take place on the set payment days of the Receiving Contracting Party.

Article 39

During the validity of this Executive Programme the Contracting Parties shall consider, if need arises, increasing the amount of money provided to the candidates as their monthly scholarship.

Article 40

All the amounts specified hereinabove (grants, scholarships, contributions, salaries or emoluments of teachers at higher education institutions) shall be disbursed to persons accepted under this Executive Programme in accordance with the relevant domestic legal regulations of the countries of the Contracting Parties.

Final provisions

Article 41

This Executive Programme shall enter into force from the day of its signature and shall remain valid until a new Executive Programme is concluded.

Conditions of exchange of arts exhibitions

Unless otherwise agreed, the exchange of exhibitions shall be organized in accordance with the following conditions:

1. The exchange of exhibitions shall be carried out on a reciprocal basis.

The sending party shall provide:

- 2. The Sending Party shall inform the Receiving Party at least six (6) months in advance about the dates and the themes of the exhibition under preparation, so that the Receiving Party can make proper arrangements for it.
- 3. The Sending Party shall provide essential technical information about the intended exhibition, as well as the indispensable materials for printing the catalogues (preface, list of objects, photos, etc.), this should be at least three (3) months before the opening, and exhibits shall reach the place of destination at least two (2) weeks before opening.
- 4. The Sending Party shall cover the costs of packing, freight and insurance of the exhibits "from nail to nail" (to the first place of exhibition and from the last place of the exhibition in Receiving country).
- 5. The Sending Party shall cover the international transport and the expenses of the representatives accompanying the exhibition.

The receiving party shall provide:

- 6. In case of any loss or damages to the exhibits, the Receiving Party shall supply the complete free-of-charge documentation referring to the cause of the loss or damage, in order to facilitate the Sending Party to claim the compensation from the insurance company. The Receiving Party is not authorized to restore the damaged exhibits to their original state without the consent of the Sending Party.
- 7. The Receiving Party shall bear the costs of organizing the exhibition, including costs of renting halls security technical assistance storage facilities installation arrangements lighting heating dismantling and printing of publications such as posters, catalogues and invitations.
- 8. The Receiving Party shall bear the costs of the internal transport related to the exhibition (from one town to another) and costs of accommodation of the representatives accompanying the exhibition.
- The Parties shall agree upon the number of persons accompanying the exhibition and their period of stay.

Exchange of individuals and groups

- 10. The Sending Party shall bear the international travel expenses to and from.
- 11. The Receiving Party shall bear the costs of full board accommodation and the internal transport according to the program of the visit (period of stay) provided that the international phone calls, alcoholic drinks and laundry are excluded.
- 12. The exchange of individuals and groups will be held in accordance with valid applicable laws of the host country.

General provisions for exchanging individuals

- 13. The Sending Party shall nominate the candidates to exchange and inform the Receiving Party about their selection at least three (3) months prior to the proposed date of departure.
- 14. The Sending Party shall provide the Receiving Party with all the necessary information related to the academic and professional qualifications of the nominated candidates and their draft work programme.
